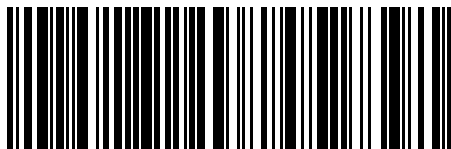

### C.

### **CRIMINAL AND CIVIL LAW VIOLATIONS**



## I.



SECTION 1. SHORT TITLE.

This Act may be cited as the “Global Anti-Semitism Review  
Act of 2004”.

22 USC 2731

SEC. 2. FINDINGS.

Congress makes the following findings:

(1) Acts of anti-Semitism in countries throughout the world,  
including some of the world’s strongest democracies, have  
increased significantly in frequency and scope over the last  
several years.

(2) During the last 3 months of 2003 and the first 3  
months of 2004, there were numerous instances of anti-Semitic  
violence around the world, including the following incidents:

Mahatir  
Mohammad.

(A) In Putrajaya, Malaysia, on October 16, 2003, former  
Prime Minister Mahatir Mohammad told the 57 national  
leaders assembled for the Organization of the Islamic Con-  
ference that Jews “rule the world by proxy”, and called  
for a “final victory” by the world’s 1.3 billion Muslims,  
who, he said, “cannot be defeated by a few million Jews.”.

(B) In Istanbul, Turkey, on November 15, 2003,  
simultaneous car bombs exploded outside two synagogues  
filled with worshippers, killing 24 people and wounding  
more than 250 people.

(C) In Australia on January 5, 2004, poison was used  
to ignite, and burn anti-Semitic slogans into, the lawns  
of the Parliament House in the state of Tasmania.

(D) In St. Petersburg, Russia, on February 15, 2004,  
vandals desecrated approximately 50 gravestones in a  
Jewish cemetery, painting the stones with swastikas and  
anti-Semitic graffiti.

(E) In Toronto, Canada, over the weekend of March  
19 through March 21, 2004, vandals attacked a Jewish  
school, a Jewish cemetery, and area synagogues, painting  
swastikas and anti-Semitic slogans on the walls of a syna-  
gogue and on residential property in a nearby, predomi-  
nantly Jewish, neighborhood.

(F) In Toulon, France, on March 23, 2004, a Jewish  
synagogue and community center were set on fire.

(3) Anti-Semitism in old and new forms is also increasingly  
emanating from the Arab and Muslim world on a sustained

basis, including through books published by government-owned publishing houses in Egypt and other Arab countries.

(4) In November 2002, state-run television in Egypt broadcast the anti-Semitic series entitled “Horseman Without a Horse”, which is based upon the fictitious conspiracy theory known as the Protocols of the Elders of Zion. The Protocols have been used throughout the last century by despots such as Adolf Hitler to justify violence against Jews.

(5) In November 2003, Arab television featured an anti-Semitic series, entitled “Ash-Shatat” (or “The Diaspora”), which depicts Jewish people hatching a plot for Jewish control of the world.

(6) The sharp rise in anti-Semitic violence has caused international organizations such as the Organization for Security and Cooperation in Europe (OSCE) to elevate, and bring renewed focus to, the issue, including the convening by the OSCE in June 2003 of a conference in Vienna dedicated solely to the issue of anti-Semitism.

(7) The OSCE convened a conference again on April 28–29, 2004, in Berlin, to address the problem of anti-Semitism with the United States delegation led by former Mayor of New York City, Ed Koch.

(8) The United States Government has strongly supported efforts to address anti-Semitism through bilateral relationships and interaction with international organizations such as the OSCE, the European Union, and the United Nations.

(9) Congress has consistently supported efforts to address the rise in anti-Semitic violence. During the 107th Congress, both the Senate and the House of Representatives passed resolutions expressing strong concern with the sharp escalation of anti-Semitic violence in Europe and calling on the Department of State to thoroughly document the phenomenon.

(10) Anti-Semitism has at times taken the form of vilification of Zionism, the Jewish national movement, and incitement against Israel.

### SEC. 3. SENSE OF CONGRESS.

It is the sense of Congress that—

(1) the United States Government should continue to strongly support efforts to combat anti-Semitism worldwide through bilateral relationships and interaction with international organizations such as the OSCE, the European Union, and the United Nations; and

(2) the Department of State should thoroughly document acts of anti-Semitism that occur around the world.

### SEC. 4. REPORTS.

Not later than November 15, 2004, the Secretary of State shall submit to the Committee on Foreign Relations of the Senate and the Committee on International Relations of the House of Representatives a one-time report on acts of anti-Semitism around the world, including a description of—

(1) acts of physical violence against, or harassment of, Jewish people, and acts of violence against, or vandalism of, Jewish community institutions, such as schools, synagogues, or cemeteries, that occurred in each country;

(2) the responses of the governments of those countries to such actions;

(3) the actions taken by such governments to enact and enforce laws relating to the protection of the right to religious freedom of Jewish people;

(4) the efforts by such governments to promote anti-bias and tolerance education; and

(5) instances of propaganda in government and nongovernment media that attempt to justify or promote racial hatred or incite acts of violence against Jewish people.

**SEC. 5. AUTHORIZATION FOR ESTABLISHMENT OF OFFICE TO MONITOR AND COMBAT ANTI-SEMITISM.**

The State Department Basic Authorities Act of 1956 is amended by adding after section 58 (22 U.S.C. 2730) the following new section:

22 USC 2731.

**“SEC. 59. MONITORING AND COMBATING ANTI-SEMITISM.**

**“(a) OFFICE TO MONITOR AND COMBAT ANTI-SEMITISM.—**

**“(1) ESTABLISHMENT OF OFFICE.—**The Secretary shall establish within the Department of State an Office to Monitor and Combat anti-Semitism (in this section referred to as the ‘Office’).

**“(2) HEAD OF OFFICE.—**

**“(A) SPECIAL ENVOY FOR MONITORING AND COMBATING ANTI-SEMITISM.—**The head of the Office shall be the Special Envoy for Monitoring and Combating anti-Semitism (in this section referred to as the ‘Special Envoy’).

**“(B) APPOINTMENT OF HEAD OF OFFICE.—**The Secretary shall appoint the Special Envoy. If the Secretary determines that such is appropriate, the Secretary may appoint the Special Envoy from among officers and employees of the Department. The Secretary may allow such officer or employee to retain the position (and the responsibilities associated with such position) held by such officer or employee prior to the appointment of such officer or employee to the position of Special Envoy under this paragraph.

**“(b) PURPOSE OF OFFICE.—**Upon establishment, the Office shall assume the primary responsibility for—

**“(1) monitoring and combating acts of anti-Semitism and anti-Semitic incitement that occur in foreign countries;**

**“(2) coordinating and assisting in the preparation of that portion of the report required by sections 116(d)(7) and 502B(b) of the Foreign Assistance Act of 1961 (22 U.S.C. 2151n(d)(7) and 2304(b)) relating to an assessment and description of the nature and extent of acts of anti-Semitism and anti-Semitic incitement for inclusion in the annual Country Reports on Human Rights Practices; and**

**“(3) coordinating and assisting in the preparation of that portion of the report required by section 102(b)(1)(A)(iv) of the International Religious Freedom Act of 1998 (22 U.S.C. 6412(b)(1)(A)(iv)) relating to an assessment and description of the nature and extent of acts of anti-Semitism and anti-Semitic incitement for inclusion in the Annual Report on International Religious Freedom.**

**“(c) CONSULTATIONS.—**The Special Envoy shall consult with domestic and international nongovernmental organizations and multilateral organizations and institutions, as the Special Envoy considers appropriate to fulfill the purposes of this section.”.

**SEC. 6. INCLUSION IN DEPARTMENT OF STATE ANNUAL REPORTS OF INFORMATION CONCERNING ACTS OF ANTI-SEMITISM IN FOREIGN COUNTRIES.**

(a) **INCLUSION IN COUNTRY REPORTS ON HUMAN RIGHTS PRACTICES.**—The Foreign Assistance Act of 1961 (22 U.S.C. 2151 et seq.) is amended—

(1) in section 116(d) (22 U.S.C. 2151n(d))—

(A) by redesignating paragraphs (8), (9), and (10), as paragraphs (9), (10), and (11), respectively; and

(B) by inserting after paragraph (7) the following new paragraph:

“(8) wherever applicable, a description of the nature and extent of acts of anti-Semitism and anti-Semitic incitement that occur during the preceding year, including descriptions of—

“(A) acts of physical violence against, or harassment of Jewish people, and acts of violence against, or vandalism of Jewish community institutions, including schools, synagogues, and cemeteries;

“(B) instances of propaganda in government and non-government media that attempt to justify or promote racial hatred or incite acts of violence against Jewish people;

“(C) the actions, if any, taken by the government of the country to respond to such violence and attacks or to eliminate such propaganda or incitement;

“(D) the actions taken by such government to enact and enforce laws relating to the protection of the right to religious freedom of Jewish people; and

“(E) the efforts of such government to promote anti-bias and tolerance education;”;

(2) after the fourth sentence of section 502B(b) (22 U.S.C. 2304(b)), by inserting the following new sentence: “Wherever applicable, a description of the nature and extent of acts of anti-Semitism and anti-Semitic incitement that occur, including the descriptions of such acts required under section 116(d)(8).”.

(b) **INCLUSION IN ANNUAL REPORT ON INTERNATIONAL RELIGIOUS FREEDOM.**—Section 102(b)(1)(A) of the International Religious Freedom Act of 1998 (22 U.S.C. 6412(b)(1)(A)) is amended—

(1) in clause (ii), by striking “and” at the end;

(2) in clause (iii), by striking the period at the end and inserting “; and”;

(3) by adding after clause (iii) the following new clause:

“(iv) wherever applicable, an assessment and description of the nature and extent of acts of anti-Semitism and anti-Semitic incitement that occur in that country during the preceding year, including—

“(I) acts of physical violence against, or harassment of, Jewish people, acts of violence against, or vandalism of, Jewish community institutions, and instances of propaganda in government and nongovernment media that incite such acts; and

“(II) the actions taken by the government of that country to respond to such violence and attacks or to eliminate such propaganda or incitement, to enact and enforce laws relating to the protection of the right to religious freedom of

(c) EFFECTIVE DATE OF INCLUSIONS.—The amendments made by subsections (a) and (b) shall apply beginning with the first report under sections 116(d) and 502B(b) of the Foreign Assistance Act of 1961 (22 U.S.C. 2151n(d) and 2304(b)) and section 102(b) of the International Religious Freedom Act of 1998 (22 U.S.C. 6312(b)) submitted more than 180 days after the date of the enactment of this Act.

# Defining Antisemitism

The Department of State has used a **working definition, along with examples, of antisemitism** since 2010. On May 26, 2016, the 31 member states of the International Holocaust Remembrance Alliance (IHRA), of which the United States is a member, adopted a non-legally binding “working definition” of antisemitism at its plenary in Bucharest. This definition is consistent with and builds upon the information contained in the 2010 State Department definition. As a member of IHRA, the United States now uses this working definition and has encouraged other governments and international organizations to use it as well.

## Bucharest, 26 May 2016

In the spirit of the Stockholm Declaration that states: “With humanity still scarred by ... antisemitism and xenophobia the international community shares a solemn responsibility to fight those evils” the committee on Antisemitism and Holocaust Denial called the IHRA Plenary in Budapest 2015 to adopt the following working definition of antisemitism.

On 26 May 2016, the Plenary in Bucharest decided to:

Adopt the following non-legally binding **working definition of antisemitism** :

“Antisemitism is a certain perception of Jews, which may be expressed as hatred toward Jews. Rhetorical and physical manifestations of antisemitism are directed toward Jewish or non-Jewish individuals and/or their property, toward Jewish community institutions and religious facilities.”

To guide IHRA in its work, the following examples may serve as illustrations:

Manifestations might include the targeting of the state of Israel, conceived as a Jewish collectivity. However, criticism of Israel similar to that leveled against any other country cannot be regarded as antisemitic. Antisemitism frequently charges Jews with conspiring to harm humanity, and it is often used to blame Jews for “why things go wrong.” It is expressed in speech, writing, visual forms and action, and employs sinister stereotypes and negative character traits.

Contemporary examples of antisemitism in public life, the media, schools, the workplace, and in the religious sphere could, taking into account the overall context, include, but are not limited to:

- ◆ Calling for, aiding, or justifying the killing or harming of Jews in the name of a radical ideology or an extremist view of religion.
- ◆ Making mendacious, dehumanizing, demonizing, or stereotypical allegations about Jews as such or the power of Jews as collective — such as, especially but not exclusively, the myth about a world Jewish conspiracy or of Jews controlling the media, economy, government or other societal institutions.
- ◆ Accusing Jews as a people of being responsible for real or imagined wrongdoing committed by a single Jewish person or group, or even for acts committed by non-Jews.
- ◆ Denying the fact, scope, mechanisms (e.g. gas chambers) or intentionality of the genocide of the Jewish people at the hands of National Socialist Germany and its supporters and accomplices during World War II (the Holocaust)
- ◆ Accusing the Jews as a people, or Israel as a state, of inventing or exaggerating the Holocaust.
- ◆ Accusing Jewish citizens of being more loyal to Israel, or to the alleged priorities of Jews worldwide, than to the interests of their own nations.
- ◆ Denying the Jewish people their right to self-determination, e.g., by claiming that the existence of a State of Israel is a racist endeavor.
- ◆ Applying double standards by requiring of it a behavior not expected or demanded of any other democratic nation.
- ◆ Using the symbols and images associated with classic antisemitism (e.g., claims of Jews killing Jesus or blood libel) to characterize Israel or Israelis.
- ◆ Drawing comparisons of contemporary Israeli policy to that of the Nazis.

- ◆ Holding Jews collectively responsible for actions of the state of Israel.

**Antisemitic acts are criminal** when they are so defined by law (for example, denial of the Holocaust or distribution of antisemitic materials in some countries).

**Criminal acts are antisemitic** when the targets of attacks, whether they are people or property – such as buildings, schools, places of worship and cemeteries – are selected because they are, or are perceived to be, Jewish or linked to Jews.

**Antisemitic discrimination** is the denial to Jews of opportunities or services available to others and is illegal in many countries.

## Enough for a minyan: A Jewish Who's Who of Biden's Cabinet-to-Be

As President-elect Joe Biden announced his picks for the Cabinet, the joke went around on Jewish Twitter that the West Wing would have a minyan.

Indeed, at least 10 prominent Jews have been nominated to key positions. There's Ronald Klain (chief of staff); Anthony Blinken (Secretary of State); Janet Yellen (Treasury); Merrick Garland (Attorney General); Alejandro Mayorkas (Homeland Security); and Avril Haines (Director of National Intelligence). One level down are Wendy Sherman (deputy Secretary of State); Eric Lander (science and technology adviser); Ann Neuberger (deputy National Security Adviser); and David Cohen (deputy CIA director).

Plus there's Doug Emhoff, the Jewish husband of Vice President-elect Kamala Harris.

It's a "remarkable statement about the place of Jews in this society," said Jason Isaacson, the American Jewish Committee's chief policy and political affairs officer in Washington. Amid the rise in antisemitism and its role underpinning the Capitol siege on Jan. 6, Isaacson added, the fact that so many well-known and engaged Jews will serve in the highest levels of the administration "and no one talks about that and it's not an issue, that says a lot about how far American society has progressed."

After Biden's inauguration on Wednesday, most of these individuals will have to be confirmed by the United States Senate. Here's a who's who guide to the West Wing minyan-to-be:

### Ronald Klain: White House Chief of Staff

Born and raised in Indianapolis, Klain, 59, said in an [interview](#) with The New York Times in 2007, that when he married his non-Jewish wife, Monica Medina, they agreed that their three children — Daniel, Hannah and Michael —

would be raised Jewish, but that the family would also celebrate Christmas.

A Harvard Law School graduate, Klain first served as chief of staff to former Vice President Al Gore and later as chief of staff to Biden during his first term as vice president. In 2014 he was appointed as President Barack Obama's Ebola response coordinator.

Klain — an active Twitter user — played a key role in drafting Biden's plan to address COVID-19 during the presidential campaign.

Tevi Troy, a historian and author of "Fight House," a book about rivalries at 1600 Pennsylvania Avenue, pointed out that a number of Jews have preceded Klain in the role. Josh Bolten was President George W. Bush's chief of staff from 2006 to 2009, followed by Rahm Emanuel and Jack Lew, who both served President Barack Obama.

While neither carried the title, Jared Kushner and Stephen Miller were perhaps President Trump's closest and most influential aides throughout his term.

### Antony Blinken: Secretary of State

Born in New York City, Blinken, 58, moved to Paris at age 9 with his mother and stepfather, Samuel Pissar, a Holocaust survivor from Poland. During the Biden campaign and in his speech accepting the nomination in December, Blinken recounted how Pissar, a lawyer, came to the U.S. after escaping a death march out of a concentration camp towards the end of WWII.

Blinken's father, Donald Blinken, served as U.S. Ambassador to Hungary under former President Bill Clinton. His uncle Alan was ambassador to Belgium during the same time. Blinken's great-grandfather, Meir Blinken, was a [Yiddish writer](#) in the early 1900s.

Also a Harvard graduate, Blinken's first government job was at the National Security Council under Clinton. He was promoted to senior director for strategic planning, then became a speechwriter for the president. During the Bush years, Blinken was staff director for the Senate Foreign Relations Committee.

Blinken worked on Biden's unsuccessful 2008 campaign for the Democratic presidential nomination, and eventually joined the Obama-Biden transition team. During Obama's first term, Blinken was Vice President Biden's national security adviser.

In 2014, he was tapped to serve as deputy to then-Secretary of State John Kerry. In recent years, Blinken was part of the WestExec

Advisors strategy advising firm and served as a senior foreign policy adviser, as well as a channel for Jewish and pro-Israel organizations, during Biden's 2020 campaign.

Blinken has also [played](#) on a Jewish Community Center indoor-soccer team in Washington, and — [along with](#) now-Congressman Tom Malinowski of New Jersey — wrote parody songs and self-parody movies on American foreign policy. The pair revived their band in Obama's state department.

Blinken's plate is pretty full for the first 100 days. He must restore morale among career diplomats who have struggled under Trump, and reestablish fraying ties with traditional allies. He will also lead diplomatic talks about rejoining the Paris climate accord, reentering the Iran nuclear deal and advancing Middle East peace. In a pre-election interview with [Jewish Insider](#), Blinken applauded the recently signed Abraham Accords between Israel and several Arab



countries as a “positive step,” but indicated that the Biden administration will also focus on reviving the Israeli – Palestinian peace process and taking the diplomatic route to tackle the Iranian threat.

Dan Shapiro, Obama’s ambassador to Israel, said that Blinken “draws on his Jewish and American family story” and “marries that with a core conviction about the essential nature of U.S. leadership in the world — to defend our people and our security, to support our allies, to confront our adversaries, to uphold our values, and to tackle the most pressing global challenges.”

As Biden’s closest foreign policy aide for two decades, Shapiro noted, Blinken will operate “with the full and complete confidence of the president.”

### Janet Yellen: Secretary of the Treasury

Born and raised by a Polish-Jewish family in Brooklyn, Yellen, 74, will make history as the first woman to head the department. The daughter of Anna Blumenthal and Julius Yellen, she was also the only woman to graduate with a Ph.D. in economics from Yale University in 1971.

Yellen went on to teach economics at Harvard before she was hired by the Federal Reserve Board of Governors to do research on international monetary reform. In 1994, Clinton appointed Yellen to the Federal Reserve’s Board of Governors. Yellen left the Federal Reserve in 1997 to become chair of Clinton’s Council of Economic Advisers, but returned in 2010, Obama elevated her to be chair of the Federal Reserve board in his second term.

Yellen was one of the people depicted in a last-minute campaign ad by Trump in 2016 that was criticized for — peddling anti-Jewish stereotypes. The ad decried the influence of “those who control the levers of power in Washington” and singled out Yellen, billionaire George Soros and Goldman Sachs CEO Lloyd Blankfein. Despite this, Yellen was initially favored for another term on the Fed, but Trump changed course and picked Jerome Powell, a Republican, a move that Yellen called disappointing.

At Treasury, Yellen’s challenges include reviving a pandemic-plagued economy, restoring some of the Trump administration’s regulatory rollbacks and leading the sanctions regime against Russia, China and Iran, among other countries.

Sheila Katz, CEO of the National Council of Jewish Women, said that in addition to being uniquely qualified for the job, Yellen “will be breaking another glass ceiling on behalf of women everywhere,” if confirmed.

### Merrick Garland: Attorney General

Garland, 68, grew up in the heavily Jewish Chicago suburb of Skokie with a father and a mother whose immigrant parents fled Russia to escape antisemitism and persecution in the early 1900s.

After graduating from Harvard, Garland worked as a clerk to legendary Second Circuit Judge Henry Friendly, and later to Supreme Court Justice William Brennan. During the Carter administration, Garland was special assistant to Attorney General Benjamin Civiletti.

In 1989, shortly after becoming a partner in a private law firm, Garland became a federal prosecutor. He had senior positions in the Clinton justice department, and since 1997, has served on the United States Court of Appeals for the District of Columbia Circuit.

President Obama’s 2016 nomination of Garland to the Supreme Court was thwarted by the Republican-controlled Senate, which refused to hold confirmation hearings because it was an election year.

“As a longtime public servant, who is also the grandson of immigrants who fled antisemitism in Russia, Merrick Garland will bring a critical perspective to the office of U.S. Attorney General,” Jonathan Greenblatt, CEO of the Anti-Defamation League, said in an interview. Greenblatt added that he’s looking forward to seeing Garland tackle the numerous challenges the country is facing, “including rising hate crimes and violent domestic extremism, and the imperative of racial justice.”

### Alejandro Mayorkas: Secretary, Dept. of Homeland Security

Born in Havana, Cuba, Mayorkas, 60, would be the first foreign-born person to run the nation’s top public security agency since its creation in 2002. His father was a Cuban native with a Sephardic background, and his mother fled Romania to Cuba amid Nazi persecution in the early 1940s. The Mayorkas family immigrated to the U.S. in 1960 following the Cuban revolution and the ascendance of Fidel Castro.

For most of the 1990s, Mayorkas served as a federal prosecutor in California focused on white-collar crime; President Clinton appointed him U.S. Attorney for Los Angeles in 1998.

In the U.S. Attorney’s office, Mayorkas created the Civil Rights Section to prosecute hate crimes and other acts of intolerance and discrimination. During the Obama administration, Mayorkas served as director of U.S. Citizenship and Immigration Services and then deputy Homeland Security secretary.

Last year, Mayorkas joined the board of the Jewish refugee aid group HIAS. Mark Hetfield, the group’s CEO, said that Mayorkas personal and family immigration history “means he has no illusions about where threats to our country come from.”

“DHS has been so focused on foreign threats, and they’ve woken up to the fact that actually most of the threats to this country are right here at home,” Hetfield added. “And I think that’s something that the Mayorkas family is familiar with — that the threads don’t always come from outside the country. So I think he’s in a good position in terms of his psyche to deal with that.”

ADL’s Greenblatt, who worked with Mayorkas in the Obama administration, described him as a “person of the highest integrity” and as someone who worked closely with Jewish groups for many years “to improve Jewish communal security.” Mayorkas, who was a volunteer lay leader at ADL, often said that his beliefs about national and communal security “were informed by the lack of security he felt as a Jew in his native Cuba,” Greenblatt added.

### Avril Haines: Director of National Intelligence

Haines, 51, grew up in Manhattan, and lost her mother at age 15. Her father, Thomas, wrote in a recent memoir that when he took her on a trip to Israel, some Israeli men encouraged her to move there.

After graduating from the University of Chicago and Georgetown University Law Center. Haines worked at the Hague Conference on Private International Law and later as a clerk for Judge Danny Julian Boggs of the U.S. Court of Appeals. She joined the State Department in 2003, and also worked on the Senate Foreign Relations Committee when Biden was its chairman.

In 2010, Haines joined the Obama White House as deputy assistant to the president and deputy counsel for national security affairs. She later served as deputy CIA director and then replaced Blinken as deputy national security adviser.

Haines was among the signatories on a letter circulated last year urging the Democratic National Committee to adopt harsher language on Israel and settlements in the party’s 2020 platform.

Like Yellen, Haines would become the first woman to hold this position.

federal government's cybersecurity efforts, a priority of the Biden administration. Neuberger joined the NSA in 2009 and served as the agency's director of cybersecurity in the past two years.

Her parents, George and Renne Karfunkel, were among the passengers on the hijacked Air France flight that landed and was rescued by Israeli commandos in Uganda's Entebbe Airport in 1976. In a 2018 [interview](#) Neuberger said she is thrilled to be seen as a role model for young women in the Jewish community.

Sherman, 71, would also become the first woman in the role; she previously made history as the first woman undersecretary of state for political affairs in 2009.

In a 2018 memoir, Sherman, who grew up in Baltimore, [recounted](#) the disappointing moment when she was notified by then-Secretary of State John Kerry that she wouldn't replace Bill Burns as deputy secretary when he retired in 2014 (Burns is Biden's nominee to head the CIA).

"On a Friday, the eve of Yom Kippur, the holiest day in the Jewish calendar, Secretary Kerry called me to his office. The president, he informed me, had decided on Tony [Blinken]," she wrote. Sherman took the news very hard, breaking into tears as she packed up to go home to the final meal before the Yom Kippur fast and for evening services at the synagogue. "I spent the holiday in mourning," she recalled.

Sherman served as lead negotiator for the Obama administration on the 2015 nuclear deal with Iran, and will likely play a prominent role in the Biden administration's negotiations with the signatories of the JCPOA and in potential talks with Tehran.

### Rachel Levine: Assistant Secretary of Health

Levine, 64, originally from Wakefield, Massachusetts, became on Tuesday the first openly transgender person nominated for a Senate-confirmed position. Currently, Levine is serving as Pennsylvania's health secretary. NCJW's Katz noted that Biden had pledged to make his Cabinet look like America, "and so far, it does." Katz said she's thrilled that for the first time, the majority of roles given to women is going to people of color. "These are diversity appointees, and that includes Jews, women, Black and indigenous people, representing the full diversity of our nation."

### Eric Lander: Director, Office of Science and Technology Policy

Another Brooklyn native, Lander, 63, was named in 2008 as co-chair of Obama's council of advisers on science and technology, a group of prominent volunteer experts from outside the federal government.

He is currently director of the Broad Institute of M.I.T. and Harvard. Biden has made the role, which has been vacant for 18 months, a Cabinet-level post; Lander is expected to be a critical adviser to the president on the coronavirus pandemic and climate change, among other issues.

### Ann Neuberger: Deputy National Security Adviser for Cybersecurity

Born and raised in Brooklyn's Orthodox neighborhood of Borough Park and a graduate of Bais Yaakov, Neuberger, 45, will serve in this newly-created role. She will be responsible for coordinating the

Nathan Diament, the Orthodox Union's executive director for public policy, called her appointment — along with Mayorkas's nomination — an "historic" moment for American Jews. "It's historic to have some of these people in these roles, and hopefully it will be good for the country," he said.

### David Cohen: Deputy CIA Director

This will be the second time serving in this role for Cohen, who is 58, grew up in Boston and graduated from Yale. In 2015, Cohen became the second highest-ranking Jew in the spy agency's hierarchy. He previously served in the treasury department as assistant secretary for terrorist financing and then undersecretary for terrorism and financial intelligence, earning the nickname of America's "sanctions guru."

Because his position does not require Senate confirmation, Cohen will become acting CIA director after Biden's inauguration until Burns's nomination as head of the agency is confirmed.

### Doug Emhoff: Second Gentleman

Emhoff, 56, does not have to await Senate confirmation, either — he will make history on Wednesday just by being the first male spouse of a Vice President.. Known to friends as "the Second Mensch", Emhoff will likely play a key role in the administration in addition to teaching law at Georgetown University.

### Is it good for the Jews?

"For the Jewish community, these announcements are a source of pride," said Ann Lewis, who served as White House director of communications for Clinton and is now co-chair of the Democratic Majority of Israel's board of directors. "I think the political-science team is shepping naches. What they mean for the country will be even greater."

Troy, who served as White House Jewish Liaison in the George W. Bush administration, said in an interview that the last 20 years has been a "golden period" for Jewish appointees in both Democratic and Republican administrations. "It's a good thing for Jews so that our views can be represented," he said. "Obviously there's more Democratic views than Republican views within our community. But the Jewish perspective definitely gets heard in administrations of both political strikes."

Tamara Cofman Wittes, a senior fellow at the Brookings Institution and a former Obama administration official, said: "It's not just their Jewish identity, but the way it informs their understanding of what America is and their approach to public service."

Wittes pointed to the remarks given by Blinken, Garland and Mayorkas when their nominations were announced, in which each alluded to their Jewish background as something that has guided them in their careers.

"These are the stories of the American Jewish community: flight from persecution, America as a place of refuge and opportunity, a place where respect for individual rights and equality under the law are not just foundational principles but fundamental to the promise this country makes to its citizens," she said. "And that means that their commitment to those principles and to realizing that promise is personal."

But Isaacson also expressed concern about “the continuing strain of antisemitism that our country has to grapple with, as we saw on display on January 6.”

“There will absolutely be enemies of the Jewish people, enemies of American pluralism, and promoters of hate and violence who will do whatever they can with the fact that a significant number of Jews are in a senior level in the Biden administration,” he said. “We can count on that and we have to be on guard against that.”

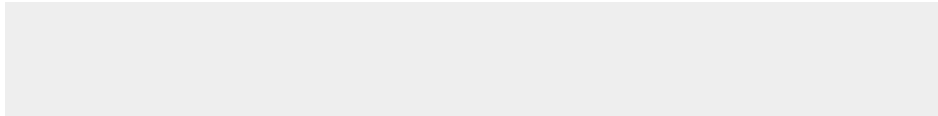
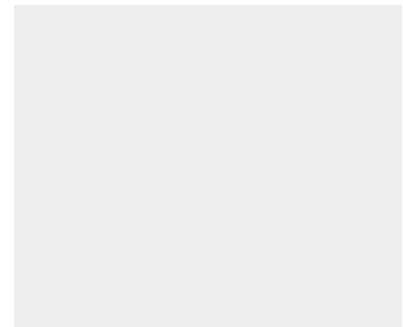
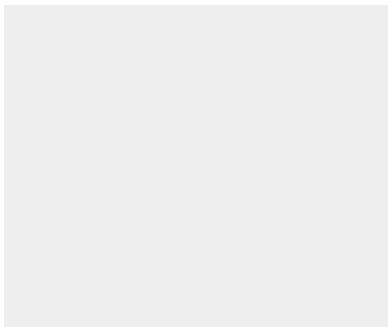

## APPENDIX I

### AN ACT TO INCORPORATE THE GENERAL EDUCATION BOARD

*Be it Enacted by the Senate and House of Representatives of the United States of America in Congress Assembled.* That William H. Baldwin, Jr., Jabez L. M. Curry, Frederick T. Gates, Daniel C. Gilman, Morris K. Jesup, Robert C. Ogden, Walter H. Page, George Foster Peabody, and Albert Shaw, and their successors, be, and they hereby are, constituted a body corporate of the District of Columbia; that the name of such body corporate shall be GENERAL EDUCATION BOARD and that by such name the said persons and their successors shall have perpetual succession.

Sec. 2. That the object of the said corporation shall be the promotion of education within the United States of America, without distinction of race, sex, or creed.

Sec. 3. That for the promotion of such object the said corporation shall have power to build, improve, enlarge, or equip, or to aid others to build, improve, enlarge, or equip, buildings for elementary or primary schools, industrial schools, technical schools, normal schools, training schools for teachers, or schools of any grade, or for higher institutions of learning, or, in connection therewith, libraries, workshops, gardens, kitchens, or other educational accessories; to establish, maintain, or endow, or aid others to establish, maintain, or endow,

elementary or primary schools, industrial schools, technical schools, normal schools, training schools for teachers, or schools of any grade, or higher institutions of learning; to employ or aid others to employ teachers and lecturers; to aid, coöperate with, or endow associations or other corporations engaged in educational work within the United States of America, or to donate to any such association or corporation any property or moneys which shall at any time be held by the said corporation hereby constituted; to collect educational statistics and information, and to publish and distribute documents and reports containing the same, and in general to do and perform all things necessary or convenient for the promotion of the object of the corporation.

Sec. 4. That the said corporation shall further have power to have and use a common seal and to alter and change the same at its pleasure; to sue or be sued in any court of the United States or other court of competent jurisdiction; to make by-laws for the admission or exclusion of its members, for the election of its trustees, officers, and agents, and otherwise; for the casting of votes by its members or trustees by proxy; for the purchase, management, sale, or transfer of its property; the investment and control of its funds and the general transaction of its business; to take or receive, whether by gift, grant, devise, bequest, or purchase, any real or personal estate, or to hold, grant, convey, hire, or lease the same for the purposes of its incorporation; to accept and administer any trust of money or of real or personal estate for any educational purpose within the object of the corporation as aforesaid; to prescribe by by-laws or otherwise the terms and conditions upon which money, real estate, or personal estate shall be acquired or received by the said corporation, and for the grant, trans-

fer, assignment, or donation of any or all property of the said corporation, real or personal, to any society or corporation for any of the said purposes for which the said corporation is hereby incorporated, and otherwise generally for the management of the property and the transaction of the business of the corporation.

Sec. 5. That the members of the corporation shall be not less than nine in number and not more than seventeen, as may be prescribed by the by-laws of the corporation: *provided, however*, That if and when the number of members shall be less than nine, the members remaining shall have power to add and shall add to their number until the number shall be not less than nine: *and provided* That no act of the corporation shall be void because at the time such act shall be done the number of the members of the corporation shall be less than nine; that all the members of the corporation shall be its trustees; that no member of the said association shall, by reason of such membership or his trusteeship, be personally liable for any of its debts or obligations; that each member of the corporation shall hold his membership for a term of three years and until his successor shall be chosen: *provided, however*, That the members shall be at all times divided into three classes numerically, as nearly as may be, and that the original members shall, at their first meeting, or as soon thereafter as shall be convenient, be divided into three classes, the members of the first class to hold their membership and office until the expiration of one year from the first day of January next after the enactment of this law, the members of the second class until the expiration of two years thereafter, and the members of the third class until the expiration of three years thereafter, and that in every case the member shall hold office after the expiration of his term

until his successor shall be chosen: *and provided further*, That, in case any member shall, by death, resignation, incapacity to act, or otherwise, cease to be a member during his term, his successor shall be chosen to serve for the remainder of such term and until his successor shall be chosen; and that the principal office of the said corporation shall be in the City of Washington, District of Columbia: *provided*, That meetings may be held elsewhere within the United States as may be determined by the members or provided by the by-laws.

Sec. 6. That all real property of the corporation within the District of Columbia which shall be used by the corporation for the educational or other purposes of the corporation as aforesaid, other than the purpose of producing income, and all personal property and funds of the corporation held, used, or invested for educational purposes as aforesaid, or to produce income to be used for such purposes, shall be exempt from taxation: *provided, however*, That this exemption shall not apply to any property of the corporation which shall not be used for, or the income of which shall not be applied to, the educational purposes of the corporation: *and provided further*, That the corporation shall annually file with the Secretary of the Interior of the United States a report in writing, stating in detail the property, real and personal, held by the corporation, and the expenditure or other use or disposition of the same or the income thereof during the preceding year.

Sec. 7. That this charter shall be subject to alteration, amendment, or repeal at the pleasure of the Congress of the United States.





# Working Definition of Antisemitism

7.06.2019



The International Holocaust Remembrance Alliance (IHRA) adopts a working definition of antisemitism on 26 May.

The consensus decision on the [adopted decision](#) was reached after in-depth discussion of the issue during the IHRA Plenary meetings held in Bucharest from 23-26 May.

IHRA Chair, Ambassador Mihnea Constantinescu, stated:

“All IHRA Member Countries share concern that incidents of antisemitism are steadily rising and agree that IHRA’s Member Countries and indeed IHRA’s experts need political tools with which to fight this scourge. IHRA’s 31 member countries- 24 of which are EU member countries- are committed to the [Stockholm Declaration](#) and thereby to fighting the evil of antisemitism through coordinated international political action.”

The IHRA Chair continued: “By adopting this working definition, the IHRA is setting an example of responsible conduct for other international fora and hopes to inspire them also to take action on a legally binding working definition.”

The Chair underlined the fact that as a body of [31 Member Countries](#), ten Observer Countries, and seven international partner organisations, with a unique mandate to focus on education, research and remembrance of the Holocaust, the IHRA was the appropriate body to adopt a working definition of antisemitism. The IHRA Chair noted the fundamental role that the German OSCE Chairmanship-in-Office played in facilitating the adoption of the working definition.



Mark Weitzman, Chair of the IHRA Committee on Antisemitism and Holocaust Denial, which proposed the adoption of the definition in 2015, said: “In order to begin to address the problem of antisemitism, there must be clarity about what antisemitism actually is. This is not a simple question. The [adopted working definition](#) helps provide guidance in answer to this challenging question. Crucially, the definition adopted by the IHRA is endorsed by experts, is relevant and is of practical applicability. Together with the IHRA adopted [Working Definition of Holocaust Denial and Distortion](#), the working definition of antisemitism provides another tool in the IHRA tool kit for combatting antisemitism.”

### Notes for Editors

The IHRA held its first bi-annual Plenary meeting under the Romanian Chairmanship from 23-26 May 2016 in Bucharest where over four days around 200 experts and policymakers from all over the world met to discuss the Holocaust as a contemporary political issue.

The IHRA's Committee on Holocaust Denial and Antisemitism was set up in order to form a common approach to address the upsurge in antisemitism and Holocaust denial and trivialization. The Committee on Antisemitism and Holocaust Denial is tasked with assessing the situation and submitting to the Plenary annual recommendations on measures to be taken to fight antisemitism in all its different forms.

IHRA is a unique intergovernmental organization which places political and social leaders' support behind the need for Holocaust education, remembrance and research both nationally and internationally.

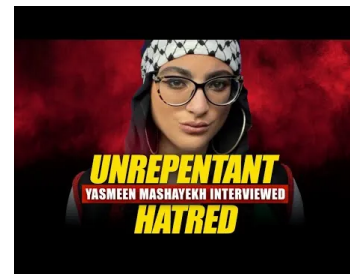

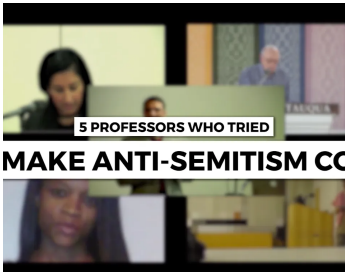

## Black Hebrew Israelites: Anti-Semitic Extremists in the Movement

### Black Hebrew Israelites

(<https://www.adl.org/resources/background-sects-within-black-hebrew-israelite-movement>) believe that black people are the real “Jews.” They claim they are the “Israelites” who descended from the biblical patriarch Jacob and his sons, known as the “12 tribes of Israel.”

A number of the groups in the movement are extremists and virulently anti-Semitic.

### Israel United in Christ (IUIC)

(<https://israelunite.org/>) is the largest of the extremist Black Hebrew Israelite groups.

IUIC’s most recent event was a mass rally in New York City in November 2022. The rally was held in support (<https://twitter.com/IUICOfficial/status/1590726978352861184>) of Brooklyn Nets NBA star Kyrie Irving who

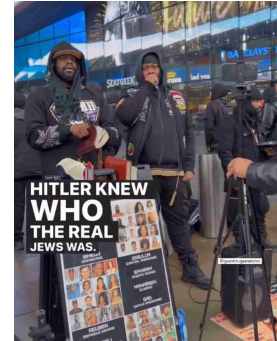

After the rally, a group of IUIC members as well as another Black Hebrew Israelite group called Sicarii gathered outside the Barclay Center, the Nets' home venue. They detailed their belief that Jews are imposters and the "synagogue of Satan. Some expressed their avid support for Hitler. Others made the common claim that Jews will become their slaves when the "real Jews wake up."

# Who are the Black Hebrew Israelites?

## Black Hebrew Israelites

(<https://www.adl.org/resources/backgrounders/extremist-sects-within-black-hebrew-israelite-movement>) believe that those who call themselves Jews today are not “real” Jews. Rather, they are “fake Jews,” imposters – Ashkenazic and Sephardic Jews alike.



There are many different groups that alternatively go by the names of Black Hebrew Israelites, Black Israelites, Black Hebrews and Hebrew Israelites. Many Black Hebrew groups also consider Hispanics and Native Americans to be part of the descendants of the biblical Israelites.

Some of the groups believe in the New Testament and in Jesus, either as a prophet or a messiah. Scripturally, these groups base their claim that blacks are the “real Jews” on a passage in the New Testament (Revelation 1:15) which states:

*“And his feet like unto fine brass, as if they burned in a furnace ...”*

Other Black Hebrews reject Christianity altogether and rely on their own interpretations of the Old Testament, the Tanach [the expanded Jewish Bible] and/or the Talmud.

Many Black Hebrews believe that because of their sins, black people were exiled from the Holy Land and sent to Africa. These groups tie certain curses prophesized in the Bible (Deuteronomy 28:15-68) to the transatlantic slave trade.

Other ills that are perceived to have befallen black people are also believed to be divine punishments for not keeping their covenant with God.

Black Hebrew groups range from peaceful to extremist and from conciliatory toward Jews to hostile. The most hostile extremist groups have capitalized on the support for the movement from the above high-profile influencers.

Although the extremist groups within the movement aren't (<https://research.lifeway.com/wp-content/uploads/2019/11/The-Philos-Project-African-American-Attitudes-Toward-Israel-Report.pdf>) the majority, they are the most visible. They are also virulently anti-Semitic.


The most prominent extremist group in the movement, Israel United in Christ, uses (<https://vimeo.com/780369289>) confrontational street preaching and slick internet promotions to spread their fanatical anti-Semitic, anti-white and anti-American ideology.

- **JEWS WORSHIP SATAN AND/OR ARE DEVILS**

## Anti-Semitic Murders and Assaults

Black Hebrew Israelite followers have been responsible for anti-Semitic murders and assaults, most recently in December 2019, when two Black Hebrew Israelites killed (https://www.adl.org/resources/backgrounders-sects-within-black-hebrew-israelite-movement) a police officer and then targeted a Jewish supermarket in Jersey City, New Jersey, where they shot and killed two people.







Menu That same month, another Black Hebrew extremist, Grafton E. Thomas, attacked (<https://www.timesofisrael.com/how-many-hebrew-israelites-are-there-and-how-worried-should-jews-be/>) a group of Orthodox Jews with a machete while they were celebrating Chanukah in Monsey, New York. A 72-year-old rabbi died from his wounds three months after the attack.



Thomas is also under investigation on suspicion of having committed a previous stabbing attack on an Orthodox Jewish man on his way to the early prayer service at 5:30 a.m. on November 20, 2019; the

in October 2019, Sally Jane Greene, a Black Hebrew follower who goes by the name of Elijah Israel, assaulted (<https://www.adl.org/resources/backgrounders/extremist-sects-within-black-hebrew-israelite-movement>) two people at a Miami synagogue while calling them "fake Jews" and telling them they should "go back to Israel."

Attacks by Black Hebrews occurred in the 1970s and 1980s as well. In 1974, a Black Hebrew opened fire in a church, killing ([https://en.wikipedia.org/wiki/Alberta\\_Williams\\_King](https://en.wikipedia.org/wiki/Alberta_Williams_King)) Alberta King, the mother of Dr. Martin Luther King, Jr.

In the 1980s, 14 people were killed (<https://www.adl.org/resources/backgrounders/extremist-sects-within-black-hebrew-israelite-movement>) by members of the Nation of Yahweh, a Black Hebrew group. Victims included people who were white and had left the sect.

Israel United in Christ (IUIC) (<https://israelunite.org/>) is the largest of the extremist Black Hebrew Israelite groups. It was founded in 2003 by Nathaniel Ray ([https://canarymission.org/individual/Nathanyel\\_Israel](https://canarymission.org/individual/Nathanyel_Israel)) who now goes by the name of Bishop Nathanyel Israel. Bishop Nathanyel leads the organization like a cult.

In his former profession as a detective with the New York Police Department, Bishop Nathanyel allegedly framed (<https://www.prisonlegalnews.org/news/2016/aug/12/7!damages-and-attorney-fees-awarded-new-york-false-arrest-case/>) two young Black men for a robbery they didn't commit. The men, who couldn't afford bail, spent 11 months in jail until the truth came out and the charges against them were dropped.

Bishop Nathanyel regularly engages in virulent anti-Semitism and anti-white racism. He also claims that blacks – specifically those that ascribe to the Black Hebrew Israelite ideology – are the “chosen” people who are “not desired by the nations [of the world].”

IUIC's goal is to recruit 144,000 Black, Latino and Native American people. Based on the book of Revelation (7:4), the group believes (<https://www.christianity.com/wiki/end-times/who-are-the-144-000-in-the-bible-is-this-number-symbolic-or-literal.html>) this is the number of people who will be spared by God at the End of Days.

Besides recruiting in North America, IUIC actively proselytizes overseas, including in Africa and the Caribbean.

## Organizational Structure

IUIC is modeled after the military. The group is “governed” by three bishops and five deacons. Below them are captains, officers and soldiers. The U.S. is divided into five regions, each of which has at least three appointed leaders — deacons, captains or both.

IUIC garnered (<https://www.charitynavigator.org/ein/200516499>) charitable status and is registered in Phoenix, Arizona. They are funded (<https://israelunite.org/donate/>) through private donations and regularly run (<https://www.facebook.com/profile.php?id=100070443494083>) fundraising campaigns online.

## Outreach and Membership

IUIC’s YouTube channel has 126,000 subscribers and almost 30 million video views. The group also runs its own Internet TV channel.



Individual IUIC chapters and members also run (<https://www.australianjewishnews.com/how-many-hebrew-israelites-are-there/>) dozens of YouTube, Facebook, Instagram and Twitter accounts where they post a constant stream of videos and memes, often containing anti-Semitic material.

In addition to its large online presence, IUIC gives Saturday classes and organizes outreach programs, often targeting economically depressed and racially diverse communities.

IUIC also organizes lectures and seminars on college campuses, including at Florida A&M University as well as the University of Buffalo and Rutgers University.



In addition, IUIC uses traditional community events as vehicles for outreach. The group mobilized hundreds of its members in public marches in Memphis (<https://www.facebook.com/watch/?v=944188795767288>) in August 2018 and Chicago (<https://www.facebook.com/watch/?v=568676690335817>) in September 2019.

## Ideology

IUIC regularly refers to Jews as the “synagogue of Satan,” a common phrase used against Jews by other anti-Semitic extremists including Nation of Islam leader Louis Farrakhan (<https://vimeo.com/canarymission>).

It is a phrase mentioned (<https://www.biblegateway.com/passage/?search=Revelation+2%3A9&version=KJV>) in two (<https://www.biblegateway.com/passage/?search=Revelation+3%3A9&version=KJV>) verses (2:9 and 3:9) in the book of Revelation and has been used ([https://en.wikipedia.org/wiki/Synagogue\\_of\\_Satan](https://en.wikipedia.org/wiki/Synagogue_of_Satan)) through the ages to justify hatred toward Jews. IUIC and Bishop Nathanyel regularly use these verses to denigrate Jews and whitewash – even justify – the Holocaust.

- For example, IUIC retweeted (<https://twitter.com/IUICOfficial/status/1601818091310153728>) a December 10, 2022 post (<https://archive.vn/wip/XkXZX>) from Bishop Nathanyel that said (<https://twitter.com/BishopNathanyel/status/1601596763495837696>): “Why are Black students forced by the public school system to study and learn Jewish Caucasian literature such as the diary of Ann Frank, Helen Keller, visit the Holocaust museum and the Simon Wiesenthal center? Read Revelation 2:9 and 3:9.”
- In 2020 (<https://archive.vn/0DZuk>), Bishop Nathanyel spoke on a Rave TV program on YouTube, saying (<https://www.youtube.com/watch?v=11yGu24QMYo&t=1199s>), “Germans and the so-called Europeans that got burned up. Six million you said, right? Six million got burnt up. They’re all the same race. They are the Edomites in the Bible. They are the devil.”
- On November 29, 2022 (<https://archive.vn/BYIL5>), Israel gave an interview to the YouTube channel GoBlack2Africa where he displayed (<https://www.youtube.com/watch?v=nroop202SDM&t=4783s>) an article (<https://jewishchronicle.timesofisrael.com/thousands-of-chabad-rabbis-convene->

in-new-york-amid-a-banner-year-for-their-movement/) about a conference ([https://www.chabad.org/library/article\\_cdo/aid/2026861/jewish/The-Annual-Conference.htm](https://www.chabad.org/library/article_cdo/aid/2026861/jewish/The-Annual-Conference.htm)) of Orthodox rabbis, who he called (<https://www.youtube.com/watch?v=nroop202SDM&t=4783s>) “fake so-called rabbis from the Jewish community.” He then accused (<https://youtu.be/nroop202SDM?t=4820>) them of “demonic activity behind the scenes.”

## Anti-Semitism and Anti-White Racism

Both anti-Semitism and anti-white racism are prominent in the extremist movements of the Black Hebrew Israelites. For example:

- In a YouTube interview in 2022 (<https://archive.vn/tsN78>), Bishop Nathanyel said (<https://www.youtube.com/watch?v=wXwihl3AU0&t=1170s>), “Let me say this about white people in Israel. They are the devil the Bible speaks of... These people are transplants. These are converts. These are not the people of God.”

In a video ([https://www.youtube.com/watch?v=7VNIVJh2k\\_0&t=6891s](https://www.youtube.com/watch?v=7VNIVJh2k_0&t=6891s)) filmed at the Western Wall in Jerusalem and uploaded to IUIC’s YouTube channel in 2019 (<https://archive.vn/OKLmS>), Benl Israel wrote a prayer on a piece of paper which he put into a crevice of the wall asking for “death to all Esau and all Edumi [Edomites],” i.e., death to all Jews and white people.

## Promoting Anti-Semitic Conspiracy Theories

From accusing Jews of Zionist plots to control the world to being behind the transatlantic slave trade, IUIC’s social media is rife with anti-Semitic conspiracy theories. For example:

- On December 10, 2022 (<https://archive.vn/x94c4>), IUIC tweeted (<https://twitter.com/IUICOfficial/status/1601646409488674817>): “Tune in at 2pm today as Deacon Yoshua continues to expose the secret plots of todays elite! Todays topic ‘The Zionist Replacement Theory Conspiracy ’ will put a spotlight on the lie they are pushing to the whole world!...”

(The “Zionist Replacement Conspiracy” is a Black Hebrew Israelite conspiracy



theory that claims (<https://www.youtube.com/watch?v=mslCi3n6684>) that the original biblical Jews were black but “Zionists” stole their identity. Thus, today’s Jews are imposters.)

- On December 4, 2022 (<https://archive.vn/wip/QCm8z>), IUIC tweeted (<https://twitter.com/IUICOfficial/status/1599328148268941318>) that Jews are “the Red Hebrew Israeli Amalekites” and accused them of “extensive involvement in the slave-trading and #HOLOCAUST of the Negroes.”

(The claim that Jews were dominant in the transatlantic slave trade was discredited (<https://www.jstor.org/stable/j.ctt9qg5gs>) in the book (<https://www.amazon.com/Jews-Slaves-Slave-Trade-Perspectives/dp/0814726380>) “Jews, Slaves, and the Slave Trade: Setting the Record Straight” by professor of History at City University, New York Eli Farber. The Amalekites, a tribe described in the Old Testament, are relentless enemies of the Jews.)

- On October 1, 2020 (<https://archive.vn/Nzc9c>), Bishop Nathanyel tweeted (<https://twitter.com/BishopNathanyel/status/1311693764382142464>): ““#BlackPeople have been #Experiencing a #Holocaust since the 1400s and the #Jewish man has #perpetuated the #Situation’...”

IUIC is based (<https://www.facebook.com/israelunited.inchrist/about>) in Mount Vernon, New York. ## Calling for the Death of Jews and White People

He placed ([https://youtu.be/7VNIVJh2k\\_0?t=6891](https://youtu.be/7VNIVJh2k_0?t=6891)) [01:54:51] a note in the Western Wall that said (<https://yc> [01:55:22]: "Death to all Esau and all Idumea [Edomites]. Rise, Israel, rise."

As stated above, IUIC claims Jews and white people are descendants of Esau (<https://en.wikipedia.org/wiki>

IUIC promoted the incident in an official IUIC YouTube video.

## Anti-Semitism

Six million got burnt. They're all the same race. They are the Edomites in the Bible. They are

Israel then addressed the men directly, saying (<https://youtu.be/11yGu24QMYo?t=1211>) [00:20:11]: "Now, le You were so adamant about six million, six! Your ancestors!... Over 200 million died during the transatlantic as horrific. You mentioned the six million of another race. You don't see that's witchcraft?"





On July 22, 2020 (<https://archive.is/5w7Lw>), IUIC tweeted (<https://twitter.com/IUICOfficial/status/128599304>) "I agree...with #Lying! We would like for the #Jewish Community to please provide #Biblical Proof of how they #Bible says to prove all things."

The tweet was accompanied by an IUIC meme that said: "JEWISH CHALLENGE / Bring forth historical bible to stop anti-Semitism."

On September 10, 2020, Israel tweeted (<https://twitter.com/BishopNathanyel/status/1304152666700996609>) introduced as "Explaining the Jew-ish myth." The video implied that black people were the "real" Jews and t

The terms "Jew-ISH" and "Je-WISH" are used (<https://www.facebook.com/photo?fbid=10153887578978187>) claim (<https://archive.ph/MEyGe>) that Jews are not "real Jews" but rather the descendants of white Europeans (<https://www.facebook.com/photo/?fbid=10153556141298187&set=a.460789618186>) themselves to be the

The video was captioned with Revelation 2:9, which reads: "I know thy works, and tribulation, and poverty, ( blasphemy of them which say they are Jews, and are not, but are the synagogue of Satan."

The phrase "synagogue of Satan" is mentioned (<https://www.biblegateway.com/passage/?search=Revelation+3%3A9&version=KJV>) verses from the New T 3:9), which have been used ([https://en.wikipedia.org/wiki/Synagogue\\_of\\_Satan](https://en.wikipedia.org/wiki/Synagogue_of_Satan)) through the ages to justify :

The tweet was accompanied by an IUIC graphic showing a man with red skin and horns.

The tweet included an image of Anti-Defamation League (ADL) director Jonathan Greenblatt (<https://www.adl.org/leadership/staff/jonathan-greenblatt>) and implied that the acronym ADL stood for Amalek's Demonic League. biblical Esau, is considered ([https://www.chabad.org/library/article\\_cdo/aid/3942715/jewish/Who-Were-Amalek](https://www.chabad.org/library/article_cdo/aid/3942715/jewish/Who-Were-Amalek)) archetypal enemy of the Jews."

The ADL was founded (<http://www.adl.org/about-adl/>) in 1913 "in response to an escalating climate of anti-Semitism. The mission is to protect the Jewish people and to secure justice and fair treatment for all."

## Promoting Anti-Semitic Conspiracy Theories

On December 10, 2022 (<https://archive.vn/x94c4>), IUIC tweeted (<https://twitter.com/IUICOfficial/status/1601>) "Yoshua continues to expose the secret plots of today's elite! Today's topic 'The Zionist Replacement Theory' lie they are pushing to the whole world!"

The "Zionist Replacement Conspiracy" is a BHI conspiracy theory. The theory claims (<https://youtu.be/mslC>) original biblical Jews were black, but that "Zionists" stole their identity, and thus today's Jews are imposters.



On December 4, 2022 (<https://archive.vn/QCm8Z>), IUIC tweeted (<https://twitter.com/IUICOfficial/status/1599>) "Red Hebrew Israeli Amalekites."

The IUIC tweet said: "Stay tuned to #IUICTV & #IUICEvents for future episodes where irrefutable, undeniable Red Hebrew Israeli Amalekites extensive involvement in the slave-trading and HOLOCAUST of the Negroes."

The claim that Jews were dominant in the transatlantic slave trade was propagated in a book ([https://en.wikipedia.org/wiki/The\\_Secret\\_Relationship\\_Between\\_Blacks\\_and\\_Jews](https://en.wikipedia.org/wiki/The_Secret_Relationship_Between_Blacks_and_Jews)) published by the Nation of Islam ([https://en.wikipedia.org/wiki/Nation\\_of\\_Islam](https://en.wikipedia.org/wiki/Nation_of_Islam)) titled: "The Secret Relationship between Blacks and Jews." This work (<https://www.jstor.org/stable/j.ctt9qg5gs>) in a work (<https://www.amazon.com/Jews-Slaves-Slave-Trade-Pers>) titled "Jews, Slaves, and the Slave Trade: Setting the Record Straight," by John Jay College of Criminal Justice professor John H. Coatsworth.

The tweet included a promotional video for an IUIC video series titled "Hidden Holocaust: Destruction of Go for the African slave trade."

On October 1, 2020 (<https://archive.vn/Nzc9c>), Israel tweeted (<https://twitter.com/BishopNathanyel/status/13>) a graphic where he was quoted as saying: "Black People Have Been Experiencing a Holocaust since the 1400s. We Perpetuated the Situation."

Another graphic featured (<https://www.facebook.com/photo/?fbid=1481863748666454&set=pcb.1481863868666442>) a quote that read: "THE JEWISH COMMUNITY ADDRESS AND APOLOGIZE FOR THEIR INVOLVEMENT IN THE GREATEST SLAVE TRADE IN HISTORY."

## Hatred of America
