If the Goods are to be manufactured or any process is to be applied to the Goods by the Seller in accordance with a specification submitted by the Buyer, the Buyer shall (without prejudice to the other rights and remedies of the Seller) indemnify the Seller in full against all loss, damages, costs expenses and other liabilities awarded against or incurred by the Seller in its consection with or paid or agreed to be paid by the Seller in sestlement of any claim for any claim for infinitenement of any patient, opportjeth, design, trade mark or other industrial or intellectual property rights of any other person which results from the Seller's use of the Buyer's specification

GENERAL.

Seller's Group The Seller is a member of the group of companies whose ultimate parent company is Advanced Medical Solutions Group pk and accordingly the Seller may perform any of its obligations or exercise any of its rights hereunder by itself or through any other member of its group, provided that any act or omission of any such other member shall be deemed to be the act or omission of the Seller.

Assignment The Seller may assign, transfer, license or sub-contract to any other person all or any part of its rights and obligations under the Contract without the Buyer's consent

Notices Any notice required or permitted to be given by either party to the other under these Conditions shall be in writing addressed to that other

party at its registered office or principal place of business or such other address as may at the relevant time have been notified pursuant to this Waivers No waiver by the Seller of any breach of the Contract by the Buyer shall be considered as a waiver of any subsequent breach of the same or

any once provision.

Severability If any provision of these Conditions is held by any competent authority to be invalid or unenforceable in whole or in part the validity of the other provisions of these Conditions and the remainder of the provision in question shall not be affected.

Arbitration Any dispute arising out of or in connection with these Conditions or the sale of the Goods, or the performance of the Services including any questions regarding its existence, validity or termination, shall be referred to and finally resolved by arbitration under the rules of the London Court of International Arbitration, which rules are deemed to be incorporated by reference into this Clause 14.6. The number of arbitrators shall be one, the seat, or legal place, or arbitration shall be London and the language to be used in the arbitral proceedings shall be and an event of the arbitrator shall be final and binding on the parties and accordingly the parties agree to exclude any right of application or appeal to the English courts concerning any question of law arising in the course of the arbitration.

Third Party Rights

Unless it expressly states otherwise and except for any member of the group of companies whose ultimate parent company is Advanced Medical Solutions Group plc, this agreement does not give rise to any rights under the Contracts (Rights of Third Parties) Act 1999 to enforce any term of

Law and Jurisdiction

The Contract shall be governed by the laws of England, and the Buyer agrees for the benefit of the Seller to submit to the non-exclusive jurisdiction of
